**[Note: We have prepared our revised Safety Plan in sequential order that follows the Department of Business & Industry Checklist that was provided to us by email on Monday, October 5, 2020. Text following a box is derived directly from the Checklist.]**

- ❑ **What signage will you post at gathering venue entrances outlining established protocols? Consider utilizing signage with easy to interpret graphics in commonly used languages reminding everyone to maintain 6 feet of distance, wear masks, wash hands, etc.**

**POSTED SIGNAGE TO ENSURE THAT EVERYONE CONFORMS TO THE GUIDELINES**

Signage is located at entrances, exits and throughout the facility on large signs, stickers and floor markers displaying protocols and instructions. Signage is an important key for consistent compliance. Please see exhibit attachments at the end of this checklist:

- *Prohibitions on entering if experiencing symptoms or have been exposed to someone with flu-like symptoms or symptoms of COVID 19*
- *Notice regarding temperature checks upon entry*
- *Notice regarding mandatory face masks (will not be permitted entry without mask) and masks must cover nose and mouth*
- *Hygiene and social distancing instructions - maintain 6 feet social distancing & limiting unnecessary physical contact such as high fives and hugs*
- *1 Parent/Guardian per registered child to maintain capacity limits*
- *Directions on entrance/exit locations to manage the flow of traffic and reduce congestion*
- *Signage in restrooms advising the correct handwashing technique and how to practice good hygiene (covering mouth and nose when coughing or sneezing - while on the field)*

- ❑ **What instructions will be posted for individuals throughout the gathering venue at entrances that inform individuals of: capacity limits, prohibitions on entering at gathering if they are experiencing symptoms, hygiene and social distancing instructions, signage and markings; and face covering requirements?**

- *Prohibitions on entering if experiencing symptoms or have been exposed to someone with flu-like symptoms or symptoms of COVID 19*
- *Notice regarding temperature checks upon entry*
- *Notice regarding mandatory face masks (will not be permitted entry without mask) and masks must cover nose and mouth*
- *Hygiene and social distancing instructions - maintain 6 feet social distancing*
- *1 Parent/Guardian per registered child to maintain capacity limits*

## **CAPACITY & MAP FOR PRACTICES & PLAY - IN-AND-OUT FLOW MANAGEMENT**

**❑ Size of venue in square feet and regular occupancy level.**

LSC is over 80,000 square feet, with an occupancy of 172. We are complying with Directive 033 that allows for 50% occupancy, which allows for 86 occupants.. Limitation on gathering in accordance with Directive 033 - 50% of occupancy.

**❑ Total number of attendees over the course of the event and maximum number of attendees will be achieved.**

The number of visitors at LSC varies depending on the programming at a specific time. At all times, maximum occupancy is at 50% of the normal occupancy level of 172.

**❑ Discuss how compliance with the maximum number of attendees will be achieved.**

People entering and exiting the facility will be counted by designated staff utilizing hand-tally counter methodology.

**❑ Discuss how the planned maximum number of attendees will be enforced.**

If the facility is at maximum occupancy, visitors will be asked to wait outside of the facility in a socially-distanced line.

For youth programming, only 1 Parent/Guardian per registered child will be permitted into the facility. Spectators are not allowed for adult programs. For rentals and other programs, a limited number of wristbands are distributed and only people with wristbands are permitted entry.

All coaches, managers, players, parents/guardians, and allowed attendees and spectators will **enter through the FRONT entrance** and **EXIT from the NORTHEAST door** in order to achieve social-distancing goals. There are signs, floor markers and staff available to direct visitors to the correct entrance/exit protocol.



## **ARRIVAL & EXITING**

- ❑ **Discuss how games and practices will be timed to allow at least a 30 minute break between the finish and start of subsequent sessions to allow for departure and arrival without congestion.**

Breaks will be implemented between sessions to allow departure and arrival without congestion. Practices and sessions will be staggered to allow for arrival and departure times for staff, players and spectators to minimize congregating at entrances, exits and restrooms to follow required physical distancing requirements. There will be separate entrances/exits for staff, players and spectators. Unlike outdoor venues, LSC has full control over entrances and exits, allowing us to limit the number of people in the facility at one time.

- ❑ **Discuss procedures for players and coaches to minimize their arrival time prior to a game or practice session.**

Players and coaches will only be permitted into the facility at least 15 minutes prior to their scheduled game time. The screening staff at the entrance will have a schedule and roster, which will allow them to admit appropriate visitors. Players, coaches and visitors are notified of this policy via weekly email.

- ❑ **Discuss procedures to require teams and spectators to depart the field or facility immediately upon completion of game or practice.**

Teams and spectators are required to depart the field or facility immediately upon completion of the session or practice. Teams are asked to leave by facility staff and are notified via weekly email.

- ❑ **Discuss procedures for players to wait in their cars with guardians until just before the beginning of practice, warm up or game, instead of forming a group.**

Players, coaches and visitors are asked to wait in their cars until at least 15 minutes before the beginning of their scheduled session. As stated above, they will not be allowed to enter the facility until such time. Players, coaches and visitors are notified of this policy via weekly email.

## **SANITIZATION SCHEDULE - CLEANING & DISINFECTION**

- ❑ **Identify areas that need to be cleaned frequently, including shared equipment, restrooms, concession stands, high touch items such as door handles, etc.**

Dedicated staff continually clean and disinfect high touch, high traffic areas and restrooms at the beginning, during and after sessions.

Areas to be continually sanitized:

- Player's boxes (benches have been removed), high touch areas wiped in between every session
- Bleachers and seating areas
- Tables and chairs located inside the Crossbar Restaurant
- Countertops at the Crossbar Restaurant and the Front Desk
- Restroom countertops, sinks and toilet areas (Restrooms are limited to 3 people at a time to prevent congestions and will be monitored by facility staff)

**❑ Identify how you will separate equipment that needs to be cleaned and disinfected before reusing.**

Pinnies (practice vests) will be organized in bags (10 pinnies per bag). Used pinnies will immediately be placed in a bin to be washed. Pinnies will be used ONCE and then washed immediately. Pinnies will NOT be provided for adult programs. Adult teams that do not provide their own pinnies or bring different color jerseys will take a forfeit (away team is always the team required to bring alternative shirts).

Participants and coaches are asked to thoroughly clean players boxes of any trash or personal items after sessions. Trash bins are located in the players boxes, throughout the facility as well as outside the facility. In between sessions, dedicated staff will sanitize the area, spraying surfaces and wiping down high-touch areas.

Players will use their own gloves, socks, shin guards and personal items. Players will bring their own balls for practice. Game balls will be provided by LSC for games. Game balls will be cleaned in between games. Designated staff (scorekeeper assigned to each field) will be responsible for sanitizing game balls.

Practice cones will only be handled by coaches and will be sanitized in between sessions. Coaches will have a "dirty" pile and "clean" pile and use the cones accordingly. ONLY sanitized cones will be available for reuse.

**❑ Develop a schedule for cleaning and disinfecting the areas identified, including, at minimum, before and after each practice and game.**

Designated staff will disinfect high-touch areas described above in between every session. During specific programming, one dedicated custodial staff will be responsible for disinfecting various areas/surfaces (this is the only job this person has to do).

**❑ Identify who will be responsible for sanitizing each area identified.**

- Player's boxes (benches have been removed), high touch areas wiped in between every session: TO BE SANITIZED BY SCOREKEEPER

- Bleachers and seating areas: TO BE SANITIZED BY DESIGNATED CUSTODIAL STAFF
- Tables and chairs located inside the Crossbar Restaurant: TO BE SANITIZED BY SERVERS
- Countertops at the Crossbar Restaurant and the Front Desk: TO BE SANITIZED BY SERVERS AND FRONT DESK STAFF
- Restroom countertops, sinks and toilet areas (Restrooms are limited to 3 people at a time to prevent congestions and will be monitored by facility staff): TO BE SANITIZED BY DESIGNATED CUSTODIAL STAFF

**❑ What sanitizers and/or disinfectants from the EPA “N” list are you using?**

The disinfectants used in the facility are from the EPA “N” List and are deemed suitable to kill SARS-CoV-2 virus. Custodial staff wear appropriate facial covering and gloves while cleaning and sanitizing.

**❑ What is the required contact time for the chosen product and how will you ensure that this is met?**

The contact time for the above product is 1 minute. The staff responsible will allow one minute before allowing visitors to touch or enter recently disinfected areas.

**❑ How will you ensure that jerseys, uniforms and other practice/game attire are washed after every use?**

LSC does not provide jerseys or uniforms to be reused. Players will use their own gloves, socks, shin guards and personal items.

Pinnies (practice vests) will be organized in bags (10 pinnies per bag). Used pinnies will immediately be placed in a bin to be washed. Pinnies will be used ONCE and then washed immediately. Pinnies will NOT be provided for adult programs. Adult teams that do not provide their own pinnies or bring different color jerseys will take a forfeit (away team is always the team required to bring alternative shirts).

**❑ How will you ensure that participants pick up their own trash at the conclusion of all games, practices and activities? Extra trash bins should be provided and more frequent disposal should occur. Where applicable, departing teams or league representatives must sanitize the team/player area.**

Participants and coaches are asked to thoroughly clean players boxes of any trash or personal items after sessions. Trash bins are located in the players boxes, throughout the facility as well as outside the facility. Trash bins will be emptied frequently by dedicated staff.

Coaches, players and visitors will be advised via weekly email to pickup trash at the conclusion of their sessions and keep track of all personal belongings and equipment. In between sessions, dedicated staff will sanitize the area, spraying surfaces and wiping down high-touch areas.

## **PERSONAL HYGIENE**

### **❑ How will you ensure that staff and players practice healthy hygiene including washing their hands frequently and covering their sneezes and coughs?**

Weekly emails are sent to participants and patrons outlining COVID precautions and protocols. Participants and patrons are informed of all rules, precautions and protocols and are encouraged to practice exceptional hygiene, which includes frequent hand washing, covering sneezes or coughs, etc. Signs indicating the same are located in restrooms and throughout the facility. All staff are trained on appropriate personal hygiene, hand washing, etc.

### **❑ Where will hand sanitizer be placed, how often will it be checked for restocking and who will be responsible for restocking?**

Hand sanitizer is available throughout the facility (see attached map), and each LSC staff will have a personal hand sanitizer spray that is provided by LSC for their own personal use as well as to spray the hands of participants. Hand sanitizer stations will be checked in between every session and restocked when necessary by designated custodial staff. All hand sanitizer stations will be refilled or topped off at the beginning of every shift.

### **❑ How will you ensure that leagues, coaches, managers and trainers have supplies for event staff and participants available, including hand sanitizer that contains at least 60% alcohol, tissues, trash baskets, disposable face masks and disinfecting products?**

LSC is an indoor recreation facility and already provides all of the above items for visitors.

## **USE OF FACE COVERINGS AND PPE**

### **❑ How will you ensure that face coverings are worn properly by coaches, managers, sports staff, officials, parents/guardians, and allowed attendees and spectators? Players and athletes must also wear face coverings indoors and outdoors, except when: actively eating or drinking, or when actively exercising or participating in practices or competitions.**

Mask and Facial Coverings are MANDATORY when entering, and when inside the facility. (except when actively eating or drinking, or when actively exercising and participating in sessions). Face coverings will be worn by coaches, managers, sports staff, officials, parents/guardians, and attendees and spectators. Players and athletes must wear face coverings except on field when actively exercising or participation in practices or sessions.

Players will always be strongly encouraged to wear face coverings to the extent practicable when actively exercising or participating in sports activities.

Face coverings must fully cover both the nose and mouth and must fit snugly against the sides of the face with no gaps. **If someone is not wearing a mask or face shield, they will be offered to purchase a mask for \$1 or they WILL BE TURNED AWAY or asked to leave.** Players over the age of 9, will have to wear a mask when outside the field.

The only time a mask becomes optional (but strongly encouraged) is for the players when on the field and involved in actively exercising or participation in practices or competition (masks are always recommended to the extent practicable). When players over the age of 9 come off the field, masks must immediately go back on.

Players and athletes must wear face coverings except when:

- Actively eating or drinking;
- If an exception can be applied under Directive 024; or
- When actively exercising or participating in practices or competitions. If social distancing cannot be maintained during activity, players are strongly encouraged to wear face coverings to the extent practicable.

**❑ Who will enforce that face coverings are worn properly for each game, practice or competition?**

Upon arrival, visitors will check in at the entrance, where dedicated staff will ensure everyone over the age of 9 years old is wearing a mask. If someone does not have a mask, masks will be provided for \$1. LSC has sufficient supply of face masks. Dedicated staff will monitor the

behavior of visitors to ensure that participants and patrons are wearing masks over their nose and mouth.

**❑ What signage will you have in place informing attendees, vendors and performers of the face covering requirements?**

Signage is located outside the facility, at entrances and throughout the facility informing attendees and visitors of the face covering requirements.

**❑ What PPE will staff use for sanitizing?**

Staff will wear appropriate masks covering their nose and mouth and medical grade gloves while cleaning and sanitizing and while preparing chemicals for sanitization procedures.

**❑ Do you have sufficient face coverings and PPE to distribute to staff and volunteers?**

LSC has sufficient supply of masks and gloves to be used by staff and visitors (if necessary).

## **SOCIAL DISTANCING**

**❑ How will you ensure staff, attendees, and participants will remain at least 6 ft apart within the venue?**

A manager, league director, or staff member will be designated to enforce all mandatory directives including social distancing, face coverings, cleaning, asking patrons to limit unnecessary physical contact, (such as high fives, handshakes and hugs), etc. All staff will be educated on COVID-19 health and safety protocols.

All parents/guardians are asked to social distance with at least six (6) feet of physical distance. Floor markers and markers on seating have been appropriately positioned to encourage social distancing. Signs have been placed throughout the facility reminding visitors to social distance by staying at least 6 ft apart from others as well as markers on floors and seating areas indicating appropriate distances for seating/standing.

Social distancing is further enforced with the following:

- Traffic arrows and guides indicating appropriate entrance/exit protocols and flow of traffic throughout the facility.
- Scheduled entry - visitors are instructed to arrive not more than 15 minutes prior to their scheduled session
- Restroom access/use - restrooms are limited to 3 people at a time (staff will monitor) and there is signage indicating this policy
- Queueing within venue - floor makers indicated where visitors should stand to maintain social distancing
- Posters - posters and signs are placed throughout the facility with social distancing instructions

- PA reminders - during certain programs, a manager will use the facility PA to remind visitors to practice social distancing (as well as other enforced rules such as wearing masks, leaving the facility immediately after sessions, etc).

**❑ How will you ensure that during times when players are not actively participating in practice or competition, that social distancing will be achieved by increasing space between players on the sideline, dugout, or bench?**

- Players and coaches will be instructed to practice social distancing while not actively participating via weekly email and signage located throughout the facility.
- Designated staff (such as a manager) will be monitoring visitor behavior to make sure social distancing is practiced on sideline or in players box.
- PA reminders - during certain programs, a manager will use the facility PA to remind visitors to practice social distancing (as well as other enforced rules such as wearing masks, leaving the facility immediately after sessions, etc).

**❑ How will you ensure that players are at least 6 feet apart on the field, when possible, while participating in the sport (such as during warmup, skill building activities and simulation drills)?**

- Players and coaches will be instructed to practice social distancing and remain at least 6 feet apart when possible, while participating in the sport (such as during warmup, skill building activities and simulation drills) via weekly email and signage located throughout the facility.
- Designated staff (such as a manager) will be monitoring visitor behavior to make sure social distancing is practiced and players remain at least 6 feet apart when possible, while participating in the sport (such as during warmup, skill building activities and simulation drills)
- PA reminders - during certain programs, a manager will use the facility PA to remind visitors to practice social distancing and remain at least 6 feet apart when possible, while participating in the sport (such as during warmup, skill building activities and simulation drills) (as well as other enforced rules such as wearing masks, leaving the facility immediately after sessions, etc).

**❑ How will you create physical distance between players when explaining drills or the rules of the game?**

Coaches and staff have been trained on keeping players 6 feet apart when possible. Coaches and patrons are encouraged to social distance when not actively participating. Dedicated staff will monitor coach and player behaviors to make sure players are 6 feet apart when explaining drills or rules of the game.

**❑ How will you prohibit unnecessary physical contact, such as high fives, handshakes, fist bumps, or hugs?**

A manager, league director, or staff member will be designated to instruct visitors to limit unnecessary physical contact, (such as high fives, handshakes and hugs), etc. Weekly emails will also be sent to all participants reinforcing social distancing guidelines and instructions regarding unnecessary physical contact. Signage posted throughout the facility will also instruct visitors to limit unnecessary physical contact, (such as high fives, handshakes and hugs), etc.

**❑ Where will the designated areas for managers and coaches, when not practicing/playing, to ensure physical distancing is maintained?**

Managers and coaches who are not actively participating in sessions will be asked to leave the facility and wait in their cars for their next session. Coaches will be allowed to dine in the restaurant at a table, if there is space available.

The Crossbar Restaurant (located inside the LSC) will be open during games. There is NO counter service available. Visitors can place their order at the counter and must proceed to their table, where a server will bring their order to them. The restaurant countertop is NOT used as a table. Crossbar does NOT have take out (customers eat food at their table).

**❑ Identify plans to limit the number of spectators admitted into the premises so that all staff, volunteers, contractors and spectators can keep six (6) feet of physical distance.**

Unlike outdoor venues, LSC has full control over entrances and exits, allowing us to limit the number of people in the facility at one time. People entering and exiting the facility will be counted by designated staff utilizing hand-tally counter methodology.

Visitors are instructed to only bring 1 parent per child and no spectators are allowed for adult programs. When visitors check in upon entry, this is enforced and patrons are reminded to social distance while at the facility.

**❑ How will you encourage players not to travel with other members of the team and only members of their immediate households?**

Coaches, players and visitors will be encouraged via weekly email to only travel with members of their immediate family (and not other team members).

**❑ How will you ensure players and spectators for sporting events do not share space, including but not limited to restrooms, hallways, concession stands?**

Coaches, players, spectators and visitors will be notified via weekly safety emails as well as ample signage throughout the facility enforcing social distancing. LSC staff will monitor visitor behavior and politely ask people to maintain safe social distances and not share spaces such as restrooms, hallways, etc.

- ❑ **Who will be responsible for monitoring and enforcing social distancing requirements for players, managers, coaches and spectators?**

Designated staff or manager on duty will be responsible for monitoring visitor behavior and enforcing social distancing requirements for players, managers, coaches and spectators.

## **SHARED EQUIPMENT & COMMONLY TOUCHED SURFACES**

- ❑ **Which equipment will be shared vs. which equipment must be solely used by one player?**

Game balls will be shared and used ONLY during scheduled games. Game balls will be wiped and sanitized at each half and in between each game.

Players may bring their own balls for personal use (players are encouraged to bring their own personal ball for warm up and single-player drills such as kicking the ball against the boards, practicing juggles, etc.) Players will bring their own personal equipment such as gloves, indoor cleats, shin guards, etc.

Practice cones will only be handled by coaches and will be sanitized after every use.

- ❑ **How will you ensure that when it is necessary to share critical or limited equipment, all surfaces of each piece of shared equipment are cleaned and disinfected frequently, as appropriate for the sport (e.g. between players, sets, periods, or games).**

Designated staff will be responsible for disinfecting game ball(s) at each half and in between each game.

Coaches and staff will disinfect practice cones in between each session.

Pinnies (practice vests) will be organized in bags (10 pinnies per bag). Used pinnies will immediately be placed in a bin to be washed. Pinnies will be used ONCE and then washed immediately. Pinnies will NOT be provided for adult programs. Adult teams that do not provide their own pinnies or bring different color jerseys will take a forfeit (away team is always the team required to bring alternative shirts).

Players will use their own gloves, socks, shin guards and personal items. Players will bring their own balls for practice. Game balls will be provided by LSC for games. Game balls will be cleaned in between games. Designated staff (scorekeeper assigned to each field) will be responsible for sanitizing game balls.

- ❑ **How will you ensure that players do not pick-up or touch another teams' equipment when not necessary for play?**

Coaches and parents will be notified via weekly email and be monitored by facility staff to ensure players do not pick up or touch another team's equipment. In most cases, teams will be isolated on their section of the field, not allowing players to go near another team's equipment

❑ **How will you require players or their family members to clean and disinfect equipment after each use?**

In most cases, the LSC provides game balls, pinnies and other equipment, which LSC will be responsible for cleaning and disinfecting according to planned protocols. If players or coaches bring their own equipment, they will be instructed to clean and sanitize the equipment after use via weekly safety email.

Participants and coaches are asked to thoroughly clean players boxes of any trash or personal items after sessions. Trash bins are located in the players boxes, throughout the facility as well as outside the facility. In between sessions, dedicated staff will sanitize the area, spraying surfaces and wiping down high-touch areas.

❑ **How will you ensure that players' personal items and equipment are spaced out at least 6 feet apart?**

Coaches, players, parents and participants will be notified via weekly safety email to keep equipment and personal belongings at least 6 feet apart. Staff will monitor.

❑ **How will you ensure players bring their own water/beverage to consume during and after games and practice?**

Weekly safety email will remind players and coaches to bring their own water/beverages to sessions and to clearly label their beverages and belongings.

❑ **How will you ensure there are no shared/communal snacks?**

Weekly safety email will inform coaches, players and visitors that team snacks are NOT permitted at this time. Staff will monitor.

❑ **How will you require players to not spit or eat sunflower seeds, gum, or other similar products?**

Spitting is NEVER allowed at LSC and will result in suspension. There are multiple signs displaying this rule and it will also be communicated in a weekly safety email.

**The NO SPITTING rule also applies to goalies spitting into their gloves. This will be communicated to players and coaches in weekly safety emails. Goalies observed spitting in their gloves will result in a red card and suspension.**

Weekly email correspondence will include reminders to players, coaches and participants of the following protocols regarding equipment:

- Players may not share or touch equipment belonging to another team
- Encourage players and parents to clean and sanitize equipment after use (particularly gloves, shin guards and re-usable masks)
- Instructing players and coaches to keep player equipment separated and at least 6 feet apart when possible
- Reminding players and coaches to bring their own water/beverages to sessions and to clearly label their beverages and belongings
- Team snacks will not be allowed

- Spitting is NEVER allowed at LSC and will result in suspension
- Coaches will be informed that players may not share equipment
- Remind players, coaches and visitors to STAY HOME if they do not feel well, if they show signs or symptoms of being sick or have been exposed to someone with similar symptoms
- Instruct visitors to enter through the front door and exit out of the northeast door
- Remind visitors that there is 1 parent permitted per child and that LSC is enforcing capacity restrictions (so there may be a socially distanced line)

Areas to be continually sanitized:

- Player's boxes (benches have been removed), high touch areas wiped in between every session
- Bleachers
- Tables and chairs located inside the restaurant
- Countertops
- Restrooms (Restrooms are limited to 3 people at a time to prevent congestions and will be monitored by facility staff)

## **HEALTH SCREENINGS, ISOLATION & TESTING**

- ❑ **How will you ensure and validate that adult coaches, managers, officials/referees and team staff have taken a COVID-19 test prior to the start of the season or resumption of athletic activity?**

OFFICIALS/REFEREES, ADULT COACHES, MANAGERS & TEAM STAFF will be required to take a COVID-19 test and will be strongly encouraged to take a COVID-19 test every other week or if any potential symptoms should arise. They will submit proof of a negative test result to the General Manager via email or in person. PLAYERS/ATHLETES: It will be strongly recommended that all players/athletes (youth) test for COVID-19.

- ❑ **If you are renting space from a local jurisdiction or private entity, discuss how you will provide verification of the results of the tests to that entity prior to commencement of any play.**

LSC is a privately owned and operated facility and will monitor tests and results.

- ❑ **Who will perform contactless temperature screenings for all players/athletes, coaches, referees/officials, league officials, staff and managers before each practice, game or other team event?**

Designated LSC staff will perform contactless temperature screenings for EVERY individual admitted to the facility. Temperatures over 100.4 degrees will NOT be allowed into the facility. Dedicated staff administer temperature checks with a contactless thermometer at the front entrance.

Contactless temperature screenings will be provided for all players/athletes, coaches, referees/officials, league officials, staff, managers, and spectators/attendees before each practice, game or other team event.

NO ONE is allowed access into the facility without a temperature check and screening survey. All coaches, managers, sports staff, officials, players, parents/guardians, and allowed attendees and spectators **will be subject to a Temperature Check**. Anyone with a temperature higher than 99.8 will NOT be permitted entry.

A touchless thermometer will be used for Temperature Checks and will be thoroughly cleaned in between each check.

Parents will be instructed to be on the alert for signs of illness in their children and themselves and stay home when sick.

- ❑ **Who will collect COVID-19 screening surveys for all participants (coaches, managers, athletes/players, referees/officials, league officials, spectators/attendees, staff?) All participants MUST respond to COVID-19 screening-survey questions upon arrival and check-in at each practice, game or other team event. “NV COVID-19 Health Screening Guide” and the “COVID Screening Check In.”**

Designated LSC staff will instruct all visitors to complete the written Screening Survey provided by NV Health Response. ALL ADULT VISITORS WILL BE REQUIRED TO SIGN IN AND FILL OUT THE WRITTEN SURVEY.

If an athlete, coach, or spectator answers “YES” to any of the survey questions, they will be advised to go home, stay away from other people, and contact their primary care provider or local health authority for further instructions.

If anyone displays symptoms of COVID-19 or if there is any suspicion that they are sick or symptomatic, they will be declined admittance to the LSC. If they arrived with other people everyone in the group will also be declined admittance.

- ❑ **What will you do if someone on-site does not pass your screening requirements?**

If an athlete, coach, or spectator answers “YES” to any of the survey questions, they will be advised to go home, stay away from other people, and contact their primary care provider or local health authority for further instructions.

If anyone displays symptoms of COVID-19 or if there is any suspicion that they are sick or symptomatic, they will be declined admittance to the LSC. If they arrived with other people everyone in the group will also be declined admittance.

- ❑ **What will you do if someone becomes ill with COVID-like symptoms on-site?**

If a visitor seems to exhibit signs of COVID 19, they will be asked to leave immediately, staff and other visitors will be notified.

## **EMPLOYEE/STAFF TRAINING & ENFORCEMENT**

### **❑ How will you train staff on cleaning, sanitizing, and disinfecting?**

Staff is trained on how to handle sanitizing chemicals, fill and spray designated areas and wipe down high touch areas where necessary. Staff are trained on using appropriate PPE such as masks and gloves while cleaning. Staff are trained by the Facility Manager in recurring training sessions that occur every other week.

### **❑ If you will be using chemicals that are corrosive or flammable, what is your Hazard Communication program?**

LSC does not use chemicals that are corrosive or flammable. However, if such chemicals are used, staff will be appropriately trained by the Facility Manager on the facility Hazard Communications Program and Safety Protocols.

### **❑ How will you train staff on face covering and PPE use?**

Staff are trained on using appropriate PPE such as masks and gloves while cleaning and while working. Safety training occur as part of weekly staff meetings and pre-shift meetings, where staff are instructed to wear masks covering their nose and mouth AT ALL TIMES, and informed on appropriate hand washing and hygiene techniques as well as how to effectively maintain social distancing from visitors and other staff members.

### **❑ How many staff/volunteers will you have to enforce capacity, social distancing and face covering requirements?**

The number of designated staff will vary depending on the time of day and the programs that are running at a given time. When there are programs running, there will ALWAYS be a designated staff member doing temperature checks. On weekends and during youth programs, there will be AT LEAST one staff member who is responsible for cleaning and sanitizing (that is all they will do). Other staff, in particular the Manager on Duty, will be responsible for monitoring the facility and behaviors of visitors to ensure proper social distancing, facial coverings and other protocols.

### **❑ What will you do when a staff member, attendee, vendor, or participant does not comply with face covering, PPE or social distancing requirements?**

If a patron, participant or attendee refuses to cooperate with the facility protocols, they will be asked to leave. LSC is a privately owned facility and reserves the right to refuse service to anyone. Management also reserves the right to suspend players or forfeit games if players, coaches or attendees do not comply with facility rules or procedures. Staff who do not comply with LSC's safety protocols will be suspended and subject to disciplinary action.

## **POSITIVE TEST PROTOCOLS AND ISOLATING**

If a coach, manager, or player/athlete of the same team tests positive for COVID-19, the entire team (if they had been in close contact with the positive individual) must be quarantined for 14 days. All team activities and practices will be canceled for 14 days during the quarantine period.

If a household member of a coach, manager, or player/athlete of the same team tests positive for COVID-19, that coach, manager, or player/athlete must notify the LSC management and must cease all activities with the team for 14 days from the most recent exposure.

If a player/athlete, coach, or team staff member becomes sick with COVID-19 and exhibits symptoms, they should notify LSC management and isolate immediately. They must cease all athletic activity and participation and must be suspended until 10 days of home isolation are completed and symptoms are resolved for at least 24 hours after that. Symptomatic cases cannot return to the team even if tests results are negative.

## **CONTACT TRACING**

LSC will instruct participants to download the COVID Trace App (<https://nvhealthresponse.nv.gov/covidtrace/>) via weekly safety email.

## **HEALTH AUTHORITY APPROVAL**




